# TERMS OF USE

Having accepted the Intermediary Terms of Business and Intermediary Data Protection Agreement, to continue using the site you are required to accept the following Terms of Use for the MBS Online Mortgage Portal:

# WHO CAN USE THE MBS ONLINE PORTAL

- 1. The MBS Online Mortgage Portal is for use by you and your authorised employees only ("Users"). By using the MBS Online Mortgage Portal, Users are accepting and agreeing to comply with these Terms of Use.
- 2. Users will ensure that all administrators nominate to use the portal, do so strictly in accordance with these Terms of Use
- 3. The MBS Online Mortgage Portal is only available to Users residing in the United Kingdom.

# ACCESSING THE MBS ONLINE MORTGAGE PORTAL

- 1. Whilst it is designed to be used with a range of internet browsers and equipment, it is the User's responsibility to provide compatible equipment and software to access the MBS Online Mortgage Portal. To continue to use the MBS Online Mortgage Portal the User must ensure their equipment and software remains fully operational and must take all reasonable steps to keep it free from viruses, bugs, other malicious code and harmful components.
